2. Having analysed the documents including affidavits submitted by School Management and recommendations of District Education Officer (Secondary Education) Sangrur, and Director, Education Officer (Secondary Education), Punjab, Chandigarh, Punjab Government hereby gives requisite No Objection Certificate subject to following conditions:

1. If during any inspection/complaint, this fact comes to light in future that while getting No Objection Certificate from government, you have applied on basis of wrong information or have not followed instructions issued by Punjab Government from time to time and conditions written in affidavits are not being fulfilled, NOC may be withdrawn at any time in such condition.
2. It shall be compulsory to teach Punjabi upto class X in your school and CBSE/ICSE, New Delhi shall compulsorily make arrangements for taking Punjabi examination in such school and it is also said along with that No Objection Certificate shall be withdrawn immediately in case of failure to do so.
3. School Management shall follow notification issued under RTE Act 2009 by Education Department, Punjab Government and RTE Act-2009 rules made for Punjab state.
4. After getting affiliation to ICSE, New Delhi, School management shall pay salary and other allowances to its teaching and non-teaching staff like government employees. No Objection Certificate shall be withdrawn immediately in case of failure to do so.
